### **Changes to Bylaws**

At the spring meeting, we will be discussing some important changes to our bylaws, which twothirds of members must vote to approve. The format of the bylaws has been updated throughout, to meet current laws and regulations, using a standard template for nonprofit organizations. We have also updated the geographical area of inclusion for membership in section 3.01, staggered terms of board members in section 4.02, and clarified the language in sections 3.09, 3.13, and throughout.
