# **New APA Shoreline Rules**

### "Grandfathered" Camps Affected

A recent *Press* Republican article reported that the Adirondack Park Agency (APA) adopted new regulations that "will overturn many properties' long-standing exemptions from setbacks that limit building within 50 to 100 feet from the water." Pre-1973 building exemptions from setbacks allowed owners "to tear down older buildings and replace them with a structure of any size..." "The new rule will require new buildings and expansions to seek a variance from the APA Board of Commissioners."

#### **New Regulation Controversial**

Certain environmental groups support the rule, whereas State legislators Senator Betty Little (R-Queensbury) and Assemblywomen Teresa Sayward (R-Willsboro) and Janet Duprey (R-Peru) are challenging the regulation. Senator Little stated that APA bypassed the legislative process when APA "expanded their legislative jurisdiction through their own rule making." It is expected by some that the APA action may be subject to litigation.


# Autumn in Loon Lake

# Town of Franklin 2009 Budget Approved

At its November 17 meeting, the Town of Franklin Board approved the Town's 2009 Budget which calls for a 4.93% increase in the Town property tax rate. The current Town tax rate is \$7.16593 per each \$1000 of assessed property value. The implied 2009 tax rate is \$7.51901 per each \$1000.

Regarding the Franklin County tax rates, the rate will increase from \$4.977841 to \$5.24678 per \$1000 of assessed value – an increase of 5.4%.

Note: Since Town of Franklin has not yet had its anticipated Real Property Assessment Reevaluation, the aforementioned tax rates do not reflect the results of a reevaluation which is expected to be completed by next Summer and to take effect in 2010.

# Town of Franklin News

As you know, the hamlet of Loon Lake is located in the Town of Franklin. Town Board decisions have an impact on all the hamlets that make up the Town. In this connection, it would be of interest to Loon Lake property owners to be aware of important Town activities and Town Board actions. Current issues of interest include the decision to repair and renovate the Town garage, erect a community center at the Town Park (Kate Mountain Park), and to enact a subdivision law.

# **Building Projects**

The apparent much needed repair, and renovation of the garage is estimated to cost \$580,000 and the Community Center cost is expected to be \$545,000; total cost \$1,125,000. The garage and community center will be considered as separate projects; the garage will have priority and the community building will be postponed indefinitely due to anticipated fiscal constraints and limited grant availability.

Funding for the garage project will come from the sale of bonds.

A recent survey of townspeople regarding the building projects revealed that most who responded favored the rehabilitation of the Town garage only, rather than both building projects.

Editor's Note: It is the opinion of this reporter that construction of a costly community building would be of practically no benefit to Loon Lake taxpayers and would have the potential to add to our taxes.

# Town Proposed Subdivision Law

The Town's Subdivision Committee, a member of which is our own Keith Silliman, is in the process of producing a document that would serve as a guideline for enforcing the regulation of subdivision of Town property into five or more lots. LLHA President Vince Pagano attended two Subdivision Committee meetings in which the Committee continued to modify a subdivision document of Hudson, NY for adoption by the Town of Franklin. Their progress has been slow. At their current rate, it is not anticipated that the document will be completed before the end of the year. However, when completed, it is expected that there will be a public hearing for comment by Town citizens.

Related to this issue, there are a significant number of Townspeople against this and any legislation that would minimize "property rights". A non-binding petition with 180 signatures against the proposed subdivision law was presented to the Town Board at a recent Town Board Meeting.

Editor's Note: Since the only existing Town property development regulatory body is the Adirondack Park Agency (APA), and considering that, in general, it does not regulate Town hamlets in this respect, it appears that the proposed law will benefit the hamlet of Loon Lake; that is, it would add an extra layer of protection against over-development of the Golf Course property; however, some believe it is not necessary because they believe the APA can regulate watershed property.

# New Town Highway Superintendent

Long time Town resident Jacques DeMars was elected Town Highway Superintendent on November 4. His two year term of office begins January 1, 2009. His election follows a year long controversy regarding the Highway Department.

Former Town Highway Superintendent James Rascoe resigned his position and Department tenure after serious allegations of alleged wrongdoing were brought against him by fellow Town highway employees. Subsequently Board - appointed Highway Superintendent Jim Perry also resigned from the Department after a short time. After that Wade Sullivan was appointed to the position but lost his bid for the 2009-10 term to Jacque Demars.

Editors Note: De Mars is retiring after many years of State service as a correction officer and is expected to bring a fresh and positive outlook to the Department. He is committed to bring about a much needed improvement and efficiency. We wish him well!

# **Aquatic Plant Survey**

Concerned about the possibility of our lake being infested with invasive plant species (e.g., Eurasian water milfoil), in 1995 LLHA commissioned Adirondack Ecologists of Crown Point, NY at the cost of \$983.00 to conduct a Survey of Loon Lake aquatic plants. The survey report concluded that the aquatic plant community of Loon Lake is typical of many Adirondack mountain lakes. A total of 25 species of aquatic plants were observed during the inventorying process and fortunately no milfoil was observed at that time (13 years ago). In addition, no zebra mussels were found.

# **Ecologists' Advisory**

The reporting ecologists advised performing a routine search for invasive species every 2 to 3 years. LLHA President Vince Pagano feels this is a priority and will be seech the LLHA Board at its next meeting to commission another survey next summer


